



NOTE

With reference to the change of personal data protection laws and the entrance into force of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation, GDPR) on 25 May 2018, **please be informed that:**

1. The Data Controller of your personal data is Global Control 5 S.A. with registered office in Warsaw (postcode 02-820), at ul. Wyczołki 71 (hereinafter referred to as the "Data Controller").
2. We process your personal data in order to conduct the recruitment process, while the legal basis for their processing is Article 6(1)(a) of GDPR.
3. The personal data we process include name, surname, telephone number, address of current/permanent residence, and other data you have provided.
4. Your personal data may be handed over to:
 - a) Providers of services for the Data Controller, especially IT or legal services, who are required to comply with the personal data protection laws;
 - b) The Data Controller's employees in relation to the performance of their work duties;
 - c) Other entities or state authorities, provided that the personal data disclosure is required by law.
5. Your data will not be transferred to third countries or international organizations.
6. Your personal data will be stored until you object to their processing or you withdraw your consent to their processing, but in no event longer than for three (3) days of the end of the recruitment process unless you consent to the processing of your personal data for the purposes of further recruitment.
7. You have the right to obtain, based on a written request, a copy of the personal data transferred to third countries and information on what measures have been taken to secure the data.
8. You have the right to access your personal data, have them rectified, removed or have their processing restricted, and object to their processing or transferring.
9. If you have any doubts with regard to the processing of your personal data, you can always turn to the Data Controller for information. You have the right to lodge a complaint with a supervisory body – the President of the Office for Personal Data Protection.
